The PLOs were updated in the academic year 2022-23 to comply with ACPHA accreditation recommendations. This initiative triggered the need for a comprehensive overhaul of our assessment plans, rubrics, and methods. The College Assessment Committee and the faculty have embraced this as a learning opportunity. Faculty need more time to adapt and adopt.

We employ a systematic assessment process, evaluating consistent learning outcomes twice per academic year, during the fall and spring semesters. Additionally, while the College Assessment Committee does not directly access individual instructors' course evaluations, the college diligently analyze a range of key student success indicators, including but not limited to DWU rates and GI 2025 markers, to inform our evaluation process as a college.
