This is always difficult to do with our small number of students. Speaking as Chair and not as PAL, some indicators that have jumped to the forefront this year, as we increase our tenure-track faculty, is tracking DFW rates for certain benchmarks courses (and alleviating wherever possible), as well as attrition rates for certain faculty advisors (and addressing high rates with those advisors).
