1. researched SLOs and compared ours to any industry standards--there aren't any--and to other programs. Across our discipline the SLOs vary widely. 2. proposed rewording to 2 of the more advanced SLOs, especially to include writing and measurable verbs as was suggested in last year's assessment report. But the other Art History faculty member is on sabbatical and so not available for discussion about how to move forward. 3. identified only 1 course that assesses at level "M." As result I brainstormed a few options to improve this. However, all will require support at every level. I have begin discussions to create a new course. I will need to consult the other Art Historian before moving forward. 4. our indirect student survey received 1 response, this needs to be an assignment in our senior seminar 5. curriculum matrix was updated and I crafted a new assessment plan, but both of those need to be discussed and approved by the other art historian.

I am also discovering upper administration seems to participate in the disconnect between positively addressing assessment outcomes and gathering data teleologically.
