

# Faculty Position Announcement Part-Time/Temporary Lecturers

The English & Modern Languages Department at California State Polytechnic University, Pomona (Cal Poly Pomona) invites lecturers to become members of our part-time temporary lecturer pool.

#### Minimum Qualifications

Master's degree in field of specialization (or master's degree in related field and relevant teaching experience) required at time of application. Teaching responsibilities include classroom lecture/discussions, grading of frequent papers, individualized instruction and scheduled office hours.

### **Preferred/Desired Qualifications**

Ph.D. in a relevant field preferred: Rhetoric and Composition, TESOL, Linguistics, English Education, French, German, Chinese (Mandarin), or Spanish.

#### **Appointments**

Part-time, temporary lecturer appointments are usually made for one academic semester (approximately 16 weeks) at fractions usually ranging from 4/15 to 12/15 of full-time; multiple semester appointments are possible. Incumbents may be reappointed to subsequent semesters contingent upon funding and favorable performance evaluations.

#### **Application Procedure**

Candidates must submit originals of:

- A completed academic application (signature is required);
- A curriculum vitae;
- Three recent letters of reference (dated within the past two years and at least one
  written within 12 months of the application). Please ask your letter writers to submit

  applicants will not be accepted;
- An official transcript from an accredited educational institution showing highest degree earned ("Issued to a student" is not considered an official transcript).
