I. Catalog Description

World of Music (3)

Introduction to selected music cultures of the world. At least one music culture from each continent will be covered. Course fulfills GE Sub-area C1.

3 hours lectures/problem solving

II. Required Coursework and Background

III. Expected Outcomes

- 1. The student will acquire greater knowledge of individual music cultures of the world.
- 2. Exposure to the musical practices and theories of various cultures will create an awareness of the students' own culture in an internationalized context.
- 3. Students will be able to identify instruments from around the world according to the Sachs- Hornbostel classification system.

The outcomes of this course relate to the following Music Department Student Learning Outcomes:

- 1. Discuss and appraise the role of music in a balanced life, using appropriate vocabulary and examples.
- 2. Communicate effectively--verbally and in writing--about specific musical works and musicians, about the creative process in music, and about music's role in human culture.
- 4. Demonstrate and articulate personal growth as a musician and student of music in the world.
- 5. Articulate a holistic understanding of the many influences on any musical endeavor (e.g., cultural, artistic, technological, economic, etc.).

VII. Course Outline

- 1. The significance and implications of ethnomusicology in describing the music cultures of the world. Music as a component of society; music makers, music consumers. Functions of music in society; religion, rites of passage, entertainment, socio-political. Musical transmission; oral, literary, origins of vocal, instrumental music.
- 2. Cultural characteristics in musics; aesthetics, social structures/musical structures, musical value, musical textures, performance contexts. Basic music theories; concepts of pitch, intervals, scales, modes (and modal modulations), mood, ornamentation. Rhythm: rhythmic components, meter, tempo. Musical/non-musical ingredients in musical performance.
- 3. Geographical, racial, linguistic, socio-cultural considerations; ensemble organizations, musical instrument-making technologies, the musical instrument maker, the performer, symbologies of musical instruments and the decorations that adorn them. Cross-cultural borrowings and influences; the musical acculturation process. Musical instrument classification systems.
- 4. Studies of music cultures from Asia, Middle East, Africa, Europe, North America, and South America.

VIII. Instructional Methods

Classes will be taught via lecture, with some use of classroom discussion in large and/or small groups, with liberal presentation of recordings and videotapes of the various music cultures. Live performances will be used when possible. Students are required to conduct their own "field" study and analyze the results.

IX. Evaluation of Outcomes

Written exams will be given. Instructors may use weekly exams or quizzes, standard midterm and final exam, or any combination.

Meaningful writing component includes at least one written concert report, a written term project in which students conduct a **field study** and write a written report on their findings, and essay questions on both midterm and final exams.
