If you are currently a Cal Grant recipient, you may request to use a portion of your remaining Cal Grant eligibility during the Summer term.

The California Student Aid Commission (CSAC) considers the summer session a full semester of eligibility. By choosing to use your Cal Grant during the summer semester, you will reduce your total program eligibility by one semester. Summer payments will reduce your total program eligibility for Cal Grant benefits. If you take the summer payment option, you might not have enough remaining eligibility to assist you during the remaining semesters of your degree program. You may verify your remaining eligibility online - on your **Webgrants for Students** account, at <https://mygrantinfo.csac.ca.gov>

Conditions of Eligibility

- Must be an undergraduate student who has not yet completed a first bachelor's degree
- Must be enrolled at Cal Poly Pomona at least half-time for the summer term
- Must have eligibility remaining at the end of the Spring 2023 term:
 - If not graduating in Summer 2023 – must have at least 100% eligibility
 - If graduating in Summer 2023 – must have at least 25% eligibility

Payment amounts for the Summer term are based on your overall enrollment status for summer and the base tuition fee you are charged; the per-unit Education Fee cannot be included. Please note the following regarding enrollment for summer and the amount of Cal Grant eligibility:
