Requirements: You must commit to 8-10 hours per week in the Spring 2026 semester. This is a 3-unit course and will meet on Monday and Wednesday morning (9 am – 12 pm) at the Pomona courthouse and every other Friday (9-10.30 am) virtually. You will also need to have a CPP professor as a reference and be interviewed by the Internship selection committee. Applications for the internship will open on Friday, October 10 and close on Friday, October 24.
