### Report to the Academic Senate 27 January, 2016

#### I. Bargaining

The third and final fact-finding meeting took place on Jan. 13th. We have been told the fact-finder's report will not be ready until mid- to late March, after which there will be a ten-day 'blackout' period, when neither side can do anything. At the end of that period, the report is made public, and CSU is likely to impose its last, 'best' offer of a 2% raise to the compensation pool for our bargaining unit, regardless of what it says. The other bargaining units (CSUEU and other staff unions) have accepted the 2% offer, but are rooting for us, owing to the "me, too" clause in their contracts (i.e., if we are given 5%, they will get that, too). After the blackout and imposition, the Board of Directors of Statewide CFA is likely to accept the faculty's strike authorization vote and call it. We will have specific, firm information on our strike plans after the Statewide CFA meeting in early Feb.
