<b>Importance to the Institution</b>	While the Religious Studies Minor arguably could contribute to preparing students for life in a multicultural world, it does not particularly promote the University mission of linking theory and practice. Nor does the Religious Studies Minor contribute in a distinctive way to the University's polytechnic identity, its learn-by-doing philosophy, or such goals as environmental sustainability. The Religious Studies Minor is not central to the aims of the Philosophy Department's existing curriculum.
<b>Quality of the Program</b>	There are two principal reasons for discontinuing the Religious Studies Minor, one related to the availability of Departmental resources to support the Minor, the other relating to demand. Currently, the courses offered to support the Minor are taught by only one full-time, tenured faculty member. As a result, the courses required for the Minor are offered only when the faculty member in question is able to offer them-typically no more than one or two per academic year. Furthermore, the Department currently has no ability to assign other instructors to replace the key faculty member in case of illness, professional leave, or retirement. Together, these factors significantly impair the Department's ability to offer and sustain a stable and rigorous minor program in Religious Studies.
<b>Efficiency and Demand for the Program</b>	The second fundamental reason for discontinuing the Religious Studies Minor is lack of sufficient student demand. While it has never been easy to track the number of students enrolled in a given minor (as opposed to major) program, it is clear to the Department that only a handful of students (four or five) have attempted to complete the Minor in the last ten years. This is by any measure simply too few students to justify the efforts needed to remedy the lack of faculty resources identified above, and that would be necessary to keep the program viable.
<b>Potential effect on the future employment status of faculty and staff in the program</b>	No current Department faculty (full or part-time, tenured or tenure track) will have his or her position in any way affected by the deletion of the Religious Studies Minor. The faculty member who currently teaches the great bulk of the courses used to fulfill the Minor will continue to teach these courses on their existing rotation.
<b>Plan/Timeline to Close the Program</b>	The Department intends to close the Religious Studies Minor with the beginning of the Fall, 2018 academic term. As far as the Department is aware, the Minor currently has zero enrollment.
