Importance to the Institution	This option has not been viable for some years as there is currently no bilingual education in K-12 education in the State of California. Students have not pursued this option for several years, and bilingual certification is earned in the post-baccalaureate credential program.		
Quality of the Program	The only difference in this subplan/option from the Pre-credential subplan/option (which has been revised to the Pre-Teaching option in semester program) is eight units in Ethnic and Women's Studies courses. This option can also be taken by students using the General Studies subplan/option.		
Efficiency and Demand for the Program	Since there are few students in this option currently and the General Studies Option is an alternate pathway, discontinuing this subplan/option will have no effect on student demand.		
Potential effect on the future employment status of faculty and staff in the program	Since there are few students in this option currently, discontinuing this subplan/option will have a negligible effect on faculty or staff in any of the service departments represented in the curriculum.		
Plan/Timeline to Close the Program	<p>Any remaining students who wish to graduate on this option will have until the end of Summer 2018 with the assistance of college academic advisers. An IAP will reflect the remaining courses to be taken in the semester program.</p> <p>Admissions - end admissions into the Bilingual Authorization Pre-Credential Option, BA/Credential Option, and Bilingual Authorization BA/Credential Option in Liberal Studies B.A. effective Winter Quarter 2018 (January 2018).</p> <p>Graduation - end graduation in Liberal Studies, B.A. in Bilingual Authorization Pre-Credential Option, BA/Credential Option, and Bilingual Authorization BA/Credential Option effective Summer 2018.</p>
