# GE Committee Summer Work

as of Monday, August 29, 2016

- **Priority 1** - the most important review priority and consists of 58 high-priority courses: 1) all of these courses have not yet been reviewed; 2) courses are prioritized in the lower/division to upper division sequence with the revisioned and converted courses [which were reclassified as revisioned] having the most immediate review priority, since these are exiting quarter courses that were revised and are expected to be in the catalog soon; 3) the rest of the courses are new courses, in the lower division to upper division priority sequence.
- **Priority 2A** - is the second priority for the review. It consists of 10 revised courses. These are the courses that have already been reviewed by the committee, but have not been completed yet. These courses are the current quarter courses that were revised and are expected to be in the catalog.
- **Priority 2B** - is the third review priority. The course list consists of 25 all new courses that are upper-division. None of these courses have been reviewed by the committee yet.
- **Priority 2C** - has 89 converted courses that have not yet been reviewed and it is recommended that at least 40% of the courses on this list are reviewed to alleviate the committee's Fall 16 workload, especially, if some of the courses on the other priority lists have been reviewed, but the committee has to wait until the F'16 term to get responses from the faculty to complete course approvals.
- **Priority 3** - courses are those that were not included in the summer 2016 work plan, yet still need to be fully reviewed in order to complete the work of the GE Committee with respect to courses submitted for the semester calendar.
