BACKGROUND: The Department of Education in the College of Education and Integrative Studies has put forward a referral for a revised semester version of the Preliminary Education Specialist Credential—Mild Moderate Disabilities. This is a revised program to provide students with more targeted content in mild/moderate disabilities and to reduce redundancy in content across courses. One new course, Characteristics of and Instructional Strategies for Students with Mild/Moderate Disabilities (EDU 5310) was created and three prerequisite courses from the program were removed (TED 406; GED 400; EDS 403). The content of these courses has been embedded in other courses (EDU 5000; EDU 5310). Rather than have a separate technology course, educational uses of educational technologies have been embedded in methods courses to demonstrate effective strategies for the K-12 classroom. The program offerings meet all State of California Commission on Teacher Credentialing Standards and Teaching Performance Expectations, as well as the Common Core State Standards.

DISCUSSION:

Before reaching the Academic Programs Committee, this program was reviewed by the Department of Education Curriculum Committee in the College of Education and Integrative Studies, as well as the Dean of the College of Education and Integrative Studies and the Office of Academic Programs. All concerns raised at those levels were addressed. The Academic Programs Committee then conducted campus-wide consultation, as well as its own review of the program. No concerns were raised.

Describe or list changes	<p>We designed the changes to the Education Specialist Mild/Moderate Disabilities Credential Program to provide students with more targeted content in mild/moderate disabilities and to reduce redundancy in content across courses. We created one new course, Characteristics of & Instructional Strategies for Students with Mild/Moderate Disabilities (EDU 5310). We removed three pre-requisite courses from the program: Educational Psychology (TED 406), Foundations of Educational Computer Literacy (GED 400), and Introduction to Special Education (EDS 403). We embedded the content in these courses into other courses (EDU 5000 - Foundations of Teaching and Learning; EDU 5310 - Characteristics of & Instructional Strategies for Students with Mild/Moderate Disabilities). Rather than have a separate technology course, we embedded educational uses of educational technologies into the methods courses to demonstrate effective teaching strategies for the K-12 classroom. The focus will also be on technological pedagogical content knowledge, which is a substantial change from how technology is currently approached in the quarter-system methods courses. The program offerings meet all State of California Commission on Teacher Credentialing (CTC) standards which include: the California Commission on Teacher Credentialing Professional Standards and Teaching Performance Expectations; and the Common Core State Standards. The program is aligned with a comprehensive program assessment plan.</p>

Program Description	<p>Through a sequence of coursework, fieldwork, and Clinical Practice, Education Specialist Credential candidates learn to develop and implement individualized education plans, evaluate data-driven goals, apply evidence-based practices for differentiated behavior and academic interventions within multi-tiered systems of support for diverse learners with mild/moderate disabilities, and develop professional collaboration skills through co-teaching, interagency and family collaboration, and case management.</p> <p>This credential authorizes the holder to teach in grades K-12 (and up to the age of 22). It includes students with autism, learning disabilities, mild/moderate intellectual disabilities, other health impairments, and emotional/behavior disorders. This credential also authorizes the holder to provide instruction for English language development and specially designed academic instruction in English (grades 12 and below and in classes organized for adults). Our programs are fully accredited by the California Commission on Teacher Credentialing and meet all state teacher preparation standards and Teaching Performance Expectations.</p>
