This is a revised semester program that includes a purposeful, developmentally designed sequence of coursework and field experience that builds upon the foundational knowledge, skills, and competencies developed in the pre-service program. It effectively prepares candidates to teach all students to read and helps candidates understand the challenges of developing literacy among California's diverse population. This certificate appeals to a wide range of grade level/content area educators because it allows for candidates to deepen their expertise and broaden their perspectives as readings specialists, while also rendering their learning relevant in the context of their particular educational settings. Changes were made to the program to meet the new state standards for the reading certificate added.
