Report to the Academic Senate Wednesday, November 29, 2017

1. CFA members and CSU Board of Trustees ratified the Faculty Contract Agreement

Over four days (October 30 through November 2, 2017) of online voting, CFA members have voted by 98 percent to ratify the tentative agreement on the faculty contract between the California Faculty Association and California State University management. The CSU Board of Trustees also ratified the agreement on November 8, 2017.

The Memorandum of Understanding between CFA and CSU management will extend our contract through June 2020, and includes a 3.5% General Salary Increase (GSI) effective Nov. 1, 2018, and a 2.5% GSI effective July 1, 2019. It protects benefits at current levels, and calls for CFA and CSU management to continue negotiations over contract provisions regarding academic freedom and intellectual property. Also, a joint panel will examine the CSU's salary structure to find ways to resolve compression and inversion in some faculty's pay.

6. Runoff for CalPERS Board Underway

A <u>runoff election</u> for CalPERS Board Member-at-Large is being held through December 11 and faculty, most of whom are CalPERS members, are asked to please vote.

The runoff election between candidates Michal Bilbrey and Margaret Brown was triggered when none of the four candidates for Position B received a majority of votes cast. Bilbrey and Brown received the highest number of votes.

Voting is held online, by phone, or by mail. Votes must be received by Dec. 11, 2017.

CFA has endorsed Michael Bilbrey for the Board position.
