BACKGROUND: The Department of Sociology has put forward a referral for a Minor in Criminology for semesters. This is a revised program. The name of the minor has been changed from 'Criminal Justice' minor. The curriculum was directly converted. Using 'Criminology' in the title of the minor is intended to better align with the new Criminology major. Overall, the change to 'Criminology' better reflects the focus on the critical study of the field within social sciences.
