Background:

Title V 40402.1 and CSU EO 665 mandate that graduate-level students shall demonstrate writing proficiency before graduation. To demonstrate writing proficiency, it has been common practice to require from all postbaccalaureate students to take and pass the Graduation Writing Test (GWT) or Graduation Writing Assessment Requirement (GWAR) as is known elsewhere in the CSU system; if they haven't taken it as part of an undergraduate requirement.

However, CSU EO 665 (C.4) allows writing proficiency certification in ways other than a test. Since many postbaccalaureate students have demonstrated writing proficiency through their undergraduate degrees before admission to the university, the GWT requirement seems to be redundant for these students.

At least one other CSU (http://www.csulb.edu/academic-advising/graduation-writing-assessment-requirement-gwar/gwar-guidelines-students) exempts the GWT requirement for graduate students who have obtained undergraduate degrees from institutions that are based in countries where the primary language for instruction is English, or if students can otherwise demonstrate writing proficiency through the GWT or GMAT tests.

It is proposed to exempt from the GWT postbaccalaureate students who have previously:

Received a degree from an accredited college or university in the United States, or received a degree from an accredited non-US institution located in a country where English is a primary language of communication; or received a score of 4 or higher on the analytical writing portion of the Graduate Record Exam (GRE) or the Graduate Management Admissions Test (GMAT).

Recommendations:

The Committee recommends the adoptions of the following Policy:

It is proposed to exempt from the GWT post-baccalaureate students who have previously:

Received a degree from an accredited college or university in the United States, or received a degree from an accredited non-US institution located in a country where English is a primary language of communication; or received a score of 4 or higher on the analytical writing portion of the Graduate Record Exam (GRE) or the Graduate Management Admissions Test (GMAT).

Students who are not exempt from the requirement, may complete the requirement in one of the following ways:

- 1) Complete the course ENG 3151: Writing for the Professions with a B- or better; OR....
- 2) Complete and pass the Graduate Writing Test (GWT)
