Situational Awareness

- Campus positivity rate continues to gradually decline, however, with the increase in campus density, we will continue to monitor this carefully.

Student Vaccination Compliance: Loss of Canvas Access

- Students who continue to remain out of compliance with original COVID-19 Vaccination policy lost access to Canvas on **Feb. 4, 2022**.
- This affected students who took no action to-date.
- Targeted email sent to affected students on Jan. 21, 2022.
- Once a student takes one of three actions (uploads vaccine record or submits a religious or medical exemption), Canvas access will be restored.

Dear Student,

According to our records, you failed to take action regarding the Cal Poly Pomona [COVID-19 vaccination requirement](#). In addition to the registration hold that has been placed on your account, **we will revoke your access to your courses on Canvas if you do not complete one of the actions to become compliant by February 4.**

We strongly encourage you to complete one of the following actions to become compliant, maintain your Canvas access and remove your registration hold:

- Be fully vaccinated and [upload your vaccine record](#) for verification
 - “Fully vaccinated” means receiving two doses of a Pfizer or Moderna vaccine, or one dose of a Johnson & Johnson vaccine **followed at least five months after by a booster dose for Pfizer or Moderna, or at least two months after for Johnson & Johnson**
- Request a [religious exemption](#)
 - A person’s sincerely held religious belief, observance, or practice, which includes any traditionally recognized religion, OR
 - Beliefs, observances, or practices which an individual sincerely holds and that occupies a place of importance in their lives, comparable to that of traditionally recognized religions.
 - Weekly COVID-19 testing **will be required** for these individuals.
- Request a [medical exemption](#)
 - Weekly COVID-19 testing **will be required** for these individuals.

If you have already completed one of the above actions and the hold has been removed, please disregard this email. You may check your health portal account regularly for updates.

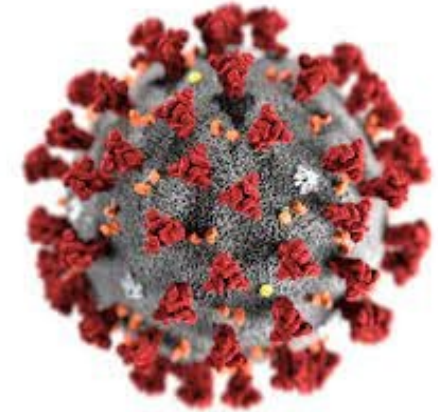

Employee/Labor Relations Updates

Update to Interim COVID-19 Vaccination Policy as of January 19, 2022

Fully Vaccinated by February 28, 2022: Completion of a vaccine primary series and are not yet eligible for any booster dose; or Completion of a vaccine primary series, and receipt of all booster dose(s) of an Approved Vaccine for which an individual is eligible per current CDC recommendations.

Boosters must be received within 30 days of an employee's eligibility.

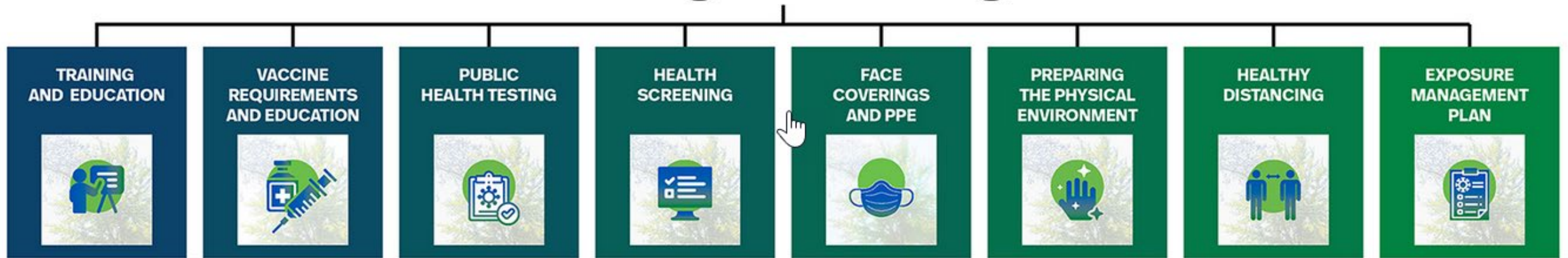
Safer Return COVID-19 Health and Safety Plan

The University's Safer Return COVID-19 Safety and Health Risk Mitigation plan reflects a multipronged approach reflecting three categories of risk mitigation:

- **Personal measures** – individual behaviors to protect ourselves and those around us
- **Administrative measures** - processes and policies that keep people safe
- **Engineering measures** - physical measures put in place to help keep our campus safe

The **eight-pronged** approach reflects *evolving* public health orders and state requirements, best practices and scientific recommendations, and local conditions. Each mitigation together serves as multiple layers to improve our ability to keep our campus and communities safe. *The plan helps assure a safer return to campus requiring individual actions and shared responsibilities.*

Enrollment Management and Services

CSU The California State University

State-Supported Enrollment

- The Chancellor's Office (CO) for the California State University System has directed campuses, through various affinity group meetings, to manage campus enrollment to within 5% of the CO funded FTES target within 3 years.

- Cal Poly Pomona is projected CY 2021-22 to be **20% above** our funded FTES target.
- We examined several enrollment reductions scenarios for our campus to be within 5% of the CO funded FTES target within 3 years.
- We decided on a Consistent Cohort model, which reduces new student enrollment with a consistent class size each year.

- Provides stability of the incoming class to allow colleges to plan course offerings, faculty needed, and budget for predictable needs.
- Allows for a clear message to our partner institutions on availability of space for incoming students.
- As our Chancellor's Office target increase, gradually increase the size of our incoming cohorts, avoiding seesaw actions.
- No longer open the Spring term for new transfer admits. Instead, use Spring to focus efforts on our **GI 2025 initiative** of re-engaging and re-enrolling underserved returning students.

Cal Poly Pomona is one of 16 CSUs and one of 45 Institutions to receive the inaugural California4All Service Corps grant. The grant will provide students the opportunity to gain valuable work experience and make a positive impact in their communities, while simultaneously earning money to help pay for their education. Students who complete a year of service will receive \$10,000 (\$7,000 stipend/living allowance, plus a \$3,000 Education Award).

#CaliforniansForAll College Corps is the first statewide service program available to [AB540 eligible Dreamers](#).

This initiative has three core goals:

Goal 1

Engage college students in meaningful service opportunities that build leadership skills and civic responsibility.

Goal 2

Help students from diverse backgrounds graduate college on time and with less debt.

Goal 3

Support the work of community-based organizations focused on key local priorities.
