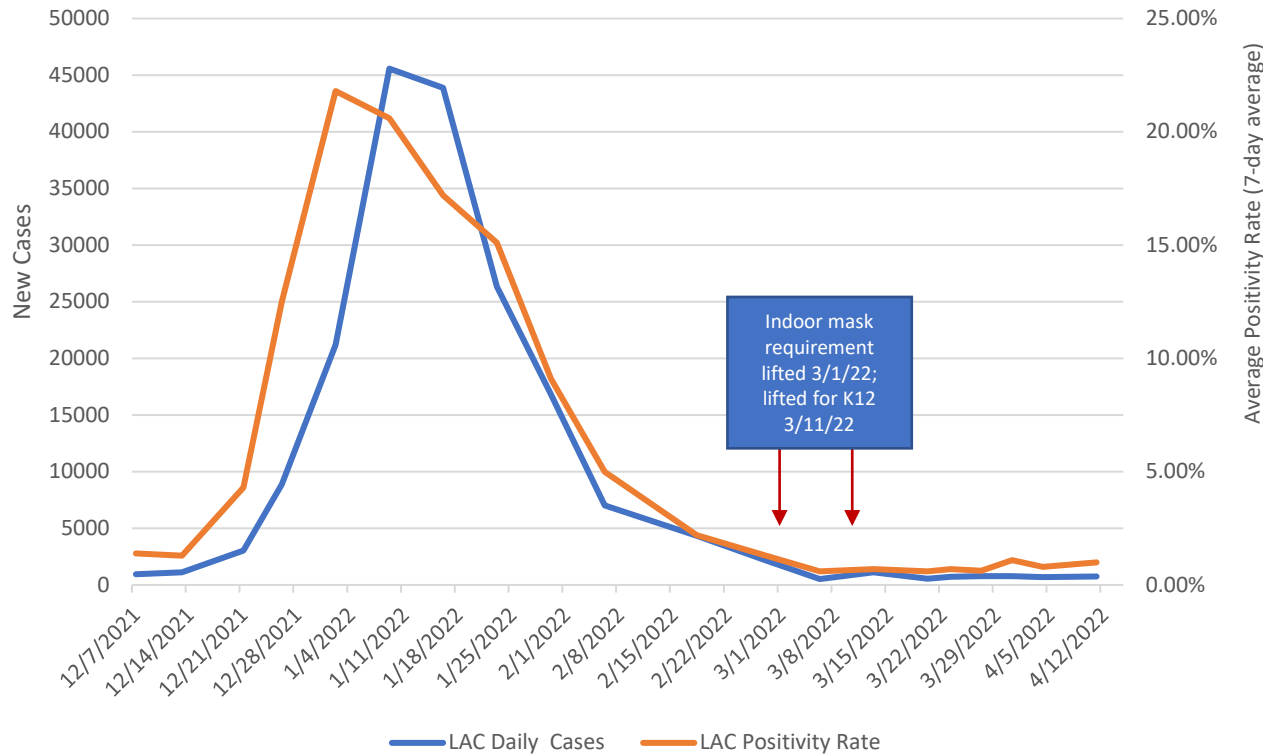

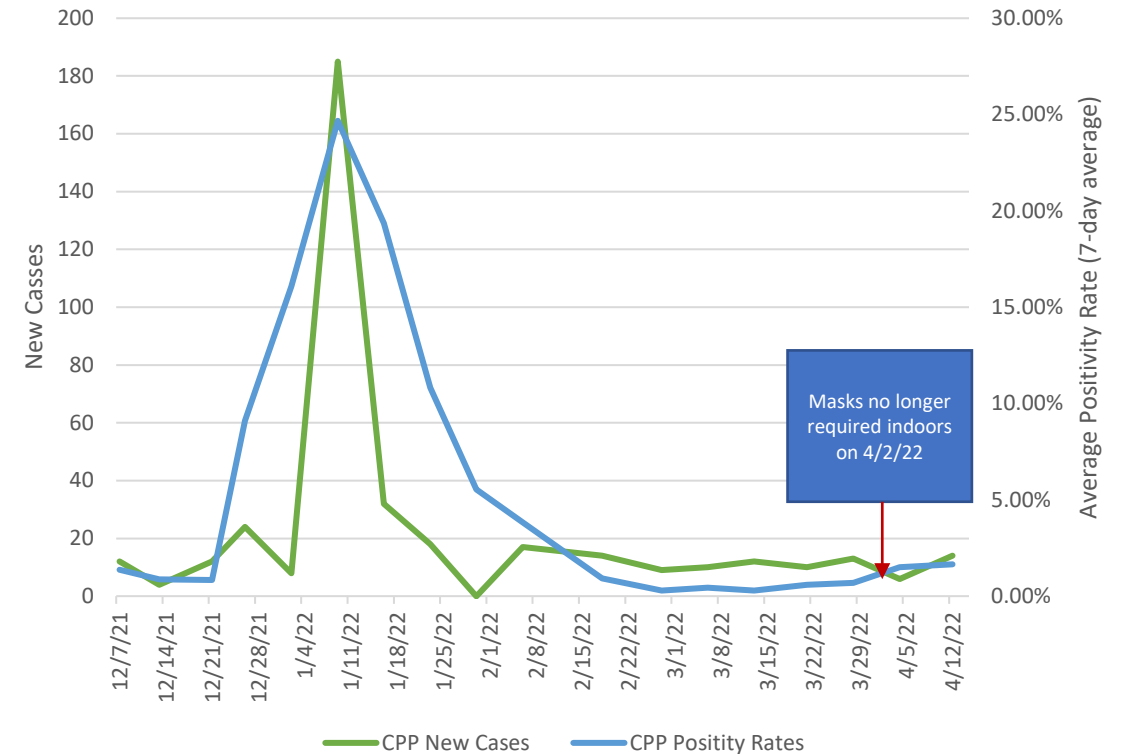

Campus Masking Requirements

1. In alignment with public health, masks will be strongly recommended indoors*, but not required effective April 2. Faculty and/or HEERA Managers cannot make it a requirement.

2. *Masks will continue to be required in certain settings:
 - a. Healthcare settings
 - b. Public transit
 - c. In alignment with public health isolation requirements

3. Masking requirements can be reinstated if conditions warrant:
 - a. By public health officials at the county or state level based on conditions, including CDC risk categories and/or variants of concern (VOC)
 - b. If we have an outbreak or cluster of cases

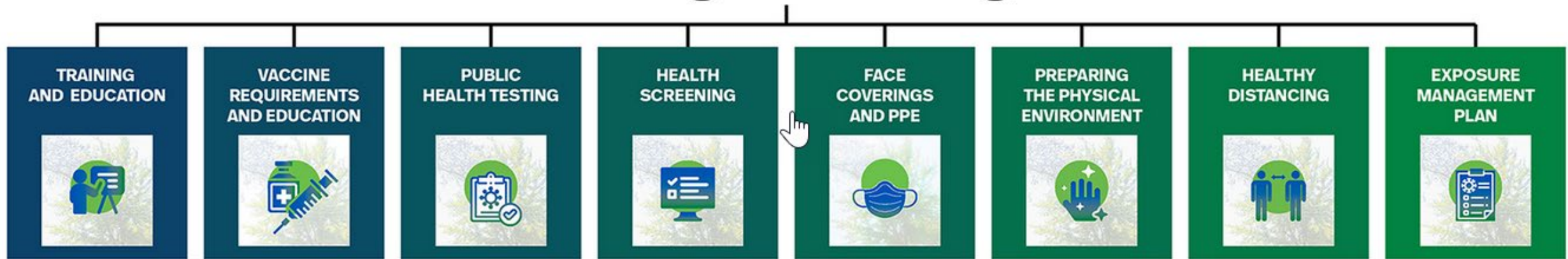
Safer Return COVID-19 Health and Safety Plan

The University's Safer Return COVID-19 Safety and Health Risk Mitigation plan reflects a multipronged approach reflecting three categories of risk mitigation:

- **Personal measures** – individual behaviors to protect ourselves and those around us
- **Administrative measures** - processes and policies that keep people safe
- **Engineering measures** - physical measures put in place to help keep our campus safe

The **eight-pronged** approach reflects *evolving* public health orders and state requirements, best practices and scientific recommendations, and local conditions. Each mitigation together serves as multiple layers to improve our ability to keep our campus and communities safe. *The plan helps assure a safer return to campus requiring individual actions and shared responsibilities.*

Summary

1. Our campus multi-pronged [health and safety plan](#) includes a layered approach to mitigate risk focusing on personal actions and collective responsibility. Masks represent one mitigation measure in our eight-pronged plan, and we will **continue to strongly recommend face coverings and provide higher grade masks at no cost.**
2. Our [Institutional Risk Response Plan](#) provides an important framework to mitigate transmission to keep our campus safer. As part of this framework, **we will continue to closely monitor a range of indicators at the campus and community level to determine if additional mitigation measures are needed.**
3. We continue to underscore the importance of testing and vaccination as two of the strongest mitigation measures for individual and collective safety. **We will continue to offer pop-up vaccination clinics and testing on campus.**
4. We will work closely with public health officials and provide timely guidance to the campus in our preparedness and planning efforts.
