**Justification for deadline**: The next academic calendar must be approved by the Senate before the end of the fall semester to comply with the Chancellor's Office deadline for submission.

**Background**: The current draft academic calendar for the 2024-25 academic year and a projection of a total of five years has been prepared. At this time, dates for the 2025 commencement and orientation sessions for 2024-25 are not available. This draft document is being submitted to ensure that the calendar can be considered by the Senate in time to comply with the Chancellor's Office deadline in January. There will be both additions (for orientation and commencement) and possible adjustment of administrative dates during Senate consideration because the draft document is currently under review by the Annual Calendar Review Committee. These changes will be communicated to the Senate as soon as they are available.

#### **Discussion**

The Academic Affairs Committee met twice to discuss the Academic Calendar. We consulted with Phyllis Nelson after a thorough review with several of our questions. Errors identified were fixed and questions were answered.

For example, in response to why Indigenous People's Day is not listed on our calendars, the answer was: "Until this is changed by state law, this can't be changed because we are part of a state institution, not an LA County institution. I am not sure of the full status of this change at this time. It is listed in our calendar because it is used for a holiday closure date to show that we have used the appropriate number of holidays. It is used as the Friday after Thanksgiving, which otherwise would be a workday."

Several drafts were sent over a period of four weeks (between September 28 and October 31) and the committee reviewed the latest draft (draft 5, attached) on November 1st.

#### Recommendations

After careful review and discussions, the Academic Affairs Committee recommends adoption of the latest revised calendar for 2024-25.
