

Installment Plans for Registration and Tuition Fees**INSTALLMENT PLANS AVAILABLE FOR REGISTRATION AND TUITION FEES**

Cal Poly Pomona students have the option, as authorized by the Board of Trustees of the California State, to pay their fees (and tuition where applicable) on an installment plan. Students owing in-state resident fees may pay in two installments, while non-resident students may pay in three installments. **This option is only available through the payment period following Priority Registration.** It is not available during the **ADD/DROP** period. PLEASE note:

- 1) THERE IS AN ADMINISTRATIVE FEE DUE IN THE INITIAL INSTALLMENT WHICH IS NON-REFUNDABLE.
- 2) ALL AUXILIARY FEES (AND PARKING IF DESIRED) MUST BE PAID IN THE INITIAL INSTALLMENT.
- 3) THE EXAMPLES BELOW USE RATES OUTLINED ON THE FEE POLICY. (See Insert)
- 4) IF ADDITIONAL FEES OR TUITION ARE DUE AFTER AN INSTALLMENT PLAN HAS BEEN ESTABLISHED, THESE AMOUNTS MAY NOT BE PAID IN INSTALLMENTS.
- 5) **STUDENTS RECEIVING FINANCIAL AID (PELL, FSEOG, CAL GRANT A, Federal Stafford Loan, Federal Perkins Loan, ACG and/or SUG) ARE ELIGIBLE FOR THIS PLAN FOR THE AMOUNT NOT COVERED BY FINANCIAL AID.**

THE FOLLOWING EXAMPLES ARE BASED ON **2016-2017** FEE RATES.

PLEASE NOTE: Be sure to write the Student ID number (BroncoNumber) on the check, and the check **MUST** be signed.

CONSEQUENCES OF NOT PAYING THE DEFERRED BALANCE:	
1)	Withholding of university services.
2)	Possible legal remedies undertaken by the University.
3)	A late payment fee of \$20.
4)	Having a negative service indicator ("hold") on the record.

For example, a resident undergraduate student taking 6.1 or more units would owe the following for WINTER 2017:

Non-Resident students normally pay the entire Registration and Tuition Fees plus \$248 per unit. The deferment plan for non-resident students includes both a one-time \$22 Administrative Fee plus 15% of the deferred portion of the tuition amount. Below is an example of a non-resident undergraduate student's payments if enrolled in 12 units, **for which the student would owe \$5,309.62 without the installment plan:**
