Executive Order No.: 674

Title: Campus User Fee for Dietetic Internship Evaluations -
California State Polytechnic University, Pomona

Effective Date: November 20, 1997

Supersedes: No Previous Executive Order

This Executive Order is issued pursuant to authority granted by Education Code 89700, Standing Orders of the Board of Trustees, Chapter III, Section 6-f-1, and Board of Trustees' Resolution RFIN 05-96-06 and consonant with Executive Order No. 661.

Effective with the Winter quarter 1998, California State Polytechnic University, Pomona is authorized to establish a campus user fee for dietetic internship evaluations in the amount of \$25. Pursuant to section 89724(a) of the Education Code, money received from this fee is appropriated for the support of the university in addition to such other amounts as may be appropriated therefor by the Legislature. Revenues received from this fee must be deposited in the State Treasury to the credit of the General Fund (Government Code Section 16300 *et seq.*).
