





**Subject:** Executive Order No. 734, Fee Waivers for California Residents, Sixty Years of Age or Older

I am transmitting a copy to you of Executive Order No. 734. This executive order supercedes and updates prior Executive Order 600 related to fee waivers for California residents, sixty years of age or older. This executive order adds the "Health Services Fee" and removes "Duplicate Degree Tuition" from the list of fees that may be waived.

In accordance with the policy of the California State University, the campus president has the responsibility for implementing executive orders where applicable and for maintaining the campus repository and index for all executive orders.

**Executive Order No.: 734**

**Title:** Fee Waivers for California Residents  
Sixty Years of Age or Older

**Effective Date:** Summer Term 2000

**Supersedes:** Executive Order No. 600

Pursuant to Education Code Section 89330 et seq. and Title 5 of the California Code of Regulations, Section 40760, I hereby delegate to the Presidents of the California State University or their designees the authority to admit for enrollment and to approve the waiver and reduction of fees for eligible California residents, sixty years of age or older who enroll in regular session courses without payment of certain fees and with reduction in the levels of others.

**I. General Provisions**

All programs implemented under this Executive Order shall adhere to the following standards:

1. Enrollment shall be limited to qualified persons who are California residents, as defined by Education Code Section 68017, and are 60 years of age or older on the residence determination date;
2. Persons enrolling in the program shall be registered last, after regular students have been registered for classes;
3. No special classes limited to, or designed for, persons enrolled pursuant to this Executive Order shall be established;
4. Fee waivers granted under the provisions of this Executive Order shall not be in place of fee waivers for disadvantaged students;

5. Persons enrolled pursuant to this Executive Order shall be otherwise eligible for admission under any one of the bases for admission set forth in Title 5 of the California Code of Regulations.


## II. Fee Waiver and Reduction

1. The following fees may be waived entirely for students enrolled pursuant to the provisions of this Executive Order:
  - a. Application Fee
  - b. State University Fee
  - c. Health Services Fee
  - d. Instructionally Related Activities Fee
2. The following fees may be reduced for students enrolled pursuant to the provisions of this Executive Order.
  - a. Student Body Association Fee
  - b. Student Body Center Fee
  - c. Health Facilities Fee

## III. Enrollment Ceilings

The President of each CSU campus shall establish the enrollment level for this program. The level established may be revised at the President's discretion.

The President of a campus implementing a program of fee waivers pursuant to this Executive Order shall maintain an annual record of the number of applicants, the number admitted, the number of waivers granted, the fees waived or reduced, revenue foregone, and FTES generated. Other information may be requested from time to time for special reports.
