Executive Order No. 812

Effective Date: March 7, 2002

Supersedes: 11

Title: Delegation of Authority

This executive order is issued under the authority of Sections 1 and 2 of Chapter III of the Standing Orders of the Board of Trustees.

The following authority is delegated to each campus president, including the authority to subdelegate to officers and employees at the campus, subject to the following limitations:

1. Issuance of Degrees, etc.:

Upon recommendation of the faculty of the campus, the campus president shall issue, on behalf of the Board of Trustees, the appropriate diploma, certificate, or degree to a student who has completed the prescribed course of study (Title 5, California Code of Regulations, Section 40400; Standing Orders of the Board of Trustees, Chapter III, Section 3.b).

2. Parietal Authority:

The campus president is authorized to require unmarried minor students of that campus who are not living with a parent or guardian to reside in private homes or other housing approved by the campus, or to occupy student housing facilities provided at the campus (Standing Orders of the Board of Trustees, Chapter III, Section 3.c).

3. Oaths:

The campus president is authorized to administer oaths of allegiance and oaths of residence (Standing Orders of the Board of Trustees, Chapter III, Section 5).

4. Tuition Determinations:


The campus president is authorized to make determinations of residence and non-residence for purposes of tuition and admission. Such determinations shall be made in accordance with the law, regulations, resolutions of the Board of Trustees, and procedures established by the chancellor, and they shall be subject to review by the

Executive Order No. 812

Office of the Chancellor on matters of law (Education Code Section 89705; Title 5, California Code of Regulations, Sections 41907 and 41908).

5. Small Claims Court Proceedings:

The campus president is authorized to initiate small claims court proceedings on behalf of the California State University in accordance with California law (Standing Orders of the Board of Trustees, Chapter III, Section 6.b).
