



Waiver of Application Fee for Students Who
Transfer Only for the Summer Quarter
Executive Order No. 124

Pursuant to Title 5, California Administrative Code, Section 41800.1(d)(4), the Visiting Student Program (Summer) is designated a special program for which an application for admission may be submitted without payment of an application fee. The Visiting Student Program (Summer) is established to more easily facilitate the transfer of certain students for the summer quarter to state colleges on quarter system year-round operation. In order to participate, a student must be regularly enrolled in a California State College during the term immediately preceding the summer quarter in which he wishes to enroll and must comply with all of the requirements for transfer. Students in this program will transfer for the summer quarter only and will not be considered continuing students at the summer quarter college but will be so considered at the college previously attended.
