



**VOLUNTEER INFORMED CONSENT AGREEMENT
RELEASE OF LIABILITY, ASSUMPTION OF RISK & AGREEMENT TO PAY CLAIMS**

In using the Cal Poly Pomona University Center for Community Engagement [CCE] Bronco Volunteer center, to locate and obtain volunteer opportunities in community-based organizations I understand and agree to the following statements:

- 1. I am at least 18 years of age.
- 2. I am a student, faculty or staff member at Cal Poly Pomona University.
- 3. There is no employee/employer relationship with the University while participating in the volunteer service and there will be no compensation for volunteering.
- 4. I am responsible for my own transportation to and from the volunteer site. The commute is my sole responsibility and expense.
- 5. I am responsible for evaluating the safety of the volunteer site. Any concerns should be brought to the attention of the community-based organization’s site manager or supervisor.
- 6. I voluntarily assume any and all risks and agree to pay any and all claims arising from or incidental to my participation in volunteer service activities/events including those that may result in:
 - a. Personal injuries including medical or hospital bills, permanent or partial disability or death.
 - b. Damage to personal property caused by or arising from participation in the volunteer service.
- 7. I will submit to the community-based organization’s required background checks and respect their rules of privacy.
- 8. I grant the University and the Center for Community Engagement Bronco Volunteer the right and permission to use photographs, film, tape or sound recordings taken of them during the course of their volunteer service for use in non-print and print media presentations.
- 9. I may be removed from participation at the community-based organization’s site with or without cause.
- 10. The University and the CCE do **not** review, evaluate or analyze community-based organizations.
- 11. The University and the CCE have no control over how the information they have provided will be used by third parties.
- 12. I will abide by “Participant Conduct Guideline and Limitations.”
- 13. I will participate in all relevant trainings required by the community-based organization.
- 14. I will model professional and appropriate behavior when working with clients and when on community-based organization site.

As a condition of using the volunteer service, I release the State of California, The Trustees of the California State University, California State Polytechnic University, Pomona, its departments the Center for Community Engagement and the Cal Poly Pomona Center for Community Engagement, Bronco Volunteer, and the employees, officers and agents of each of them from Liability for personal injury, wrongful death and property damage arising from participation in any events or activities associated with the Bronco Volunteer Center.

The attached “Volunteer Participant Guidelines and Limitations”, consisting of one page, is incorporated by reference and made a part of this agreement.
